FOREIGN SCHOLARS GOING TO INDIA FOR RESEARCH

The scholar who intends to go to India for research follow the following procedures for obtaining Research Visa.

- (a) Application should be made for approval of research project on the enclosed prescribed form. After completion of the form a passport size photograph should be affixed at the space provided for on the first page of the form. The details of the research project on a separate sheet of paper may also be attached with the application. It is necessary that scholar should be affiliated to a university or relevant Institution in India and a Certificate in this regard should be obtained and enclosed with the application. A form for this purpose is also enclosed. After having completed above procedure 10 sets of application (photocopied) be made and forwarded to the Science & Education Department of the High Commission.
- (b) The application will be sent to the department of Education. Ministry of Human Resource Development for approval of the research project which may take about three months. Therefore , it is advisable to submit application well ahead of the scheduled date for commencement of research work in India.
- (c) The decision of the government will be communicated to scholar in due course and necessary instruction will follow how to obtain research visa from the Visa Section of this High Commission.
